

## TERMS AND CONDITIONS

### “EPF i-Invest with Principal – 2022 Get Ahead Promotion”

1. “EPF i-Invest with Principal – 2022 Get Ahead Promotion (“**Promotion**”) is organised by Principal Asset Management Berhad (Company No. 199401018399 (304078-K)) (“Principal”) and shall be subject to the terms and conditions herein (“**Terms and Conditions**”).
2. By participating in this Promotion, the Eligible Participant (as defined in Clause 5 below) hereby expressly agrees to be bound by these Terms and Conditions. You can also view additional applicable terms of use as well as any other applicable terms and conditions imposed by Principal which are available on Principal’s official website ([www.principal.com.my](http://www.principal.com.my)). Please read all related Terms and Conditions as well as any other applicable terms of use and/or terms of conditions carefully before participating in this Promotion.

### Promotion Period

3. Promotion Period is from 3<sup>rd</sup> January 2022 to 9<sup>th</sup> January 2022, 11.59 PM, both dates inclusive (“**Promotion Period**”).
4. Principal reserves its absolute right and discretion to vary or amend the Promotion Period at any time without prior notice, without assigning any reason whatsoever.

### Eligibility

5. To be eligible, a participant must fulfill the following criteria:
  - a) invested a minimum of RM25,000 in Principal’s unit trust funds (“Funds”) at any time during the Promotion Period via EPF i-Akaun (<https://www.kwsp.gov.my/member/investment>) AND Principal investment portal (<https://secure01.principal.com.my>) (collectively referred to as “EPF i-Invest”);
  - b) an existing or new EPF i-Invest user of Principal Asset Management Berhad; and
  - c) has satisfied the Conditions (as defined in Clause 7 below) (Collectively referred to as “**Eligible Participant**”).
6. The following individual shall not be able to participate in this Promotion:
  - a) **if investment made through Principal’s consultant.**

### Promotion Mechanics and Conditions

    - i. redemption from an existing investment;

#### **Terms and Conditions of the Touch 'n Go eWallet Reload PINs ("TNG Reload PINs")**

15. The Terms and Conditions of the TNG Reload PINs are as follows:
  - a) Principal will email the TNG Reload PINs in the form of unique e-code issued by Touch 'n Go to the registered email address which Eligible Participant has provided to Principal.
  - b) The Eligible Participants are responsible for redeeming the TNG Reload PINs directly through the Touch 'n Go eWallet App as stated in the registered email sent by Principal within the validity of the unique e-code;
  - c) Each Eligible Participant is only entitled to one TNG Reload PINs (one code per Eligible Participant) during the Promotion Period regardless of number of investments made;
  - d) If the TNG Reload PINs remains unused or unredeemed after the said Promotion Period, the TNG Reload Pin shall lapse and will not be replaced; and
  - e) The usage of the TNG Reload PINs is subject to the Touch 'n Go eWallet User Terms and Conditions available in the Touch 'n Go eWallet official website. Eligible Participants are responsible to read and understand the Touch 'n Go's security and privacy policies and terms and conditions available in the Touch 'n Go eWallet official website.

#### **Terms and Conditions of the Funds**

16. The terms and conditions governing the Funds are specified in the relevant master prospectus(es), supplemental prospectus(es) or information memorandum thereto (if any) that have been duly registered and duly lodged with the Securities Commission Malaysia which shall be governed by and regulated in accordance with the Capital Markets and Services Act 2007 (as amended) and the relevant guidelines and directives issued by the relevant authorities.
17. The Eligible Participant shall be solely liable to make their own independent evaluation of the Funds and any information made available pertaining to the Funds, including the relevant master prospectus(es), supplemental prospectus(es), or information memorandum thereto (if any) and seek independent financial, legal or other advice regarding the appropriateness of investing in any of the Funds. Principal shall not be liable for any investment decision made by the Eligible Participant pertaining to the Promotion or the Funds.
