

TERMS AND CONDITIONS

“Switch and Get Rewarded”

1. “Switch and Get Rewarded” (“**Promotion**”) is organized by Principal Asset Management Berhad (Company No. 199401018399 (304078-K)) (“Principal”) and shall be subject to the terms and conditions herein (“**Terms and Conditions**”).
2. By participating in this Promotion, the Eligible Participant (as defined in Clause 5 below) hereby expressly agrees to be bound by these Terms and Conditions. You can also view additional applicable terms of use as well as any other applicable terms and conditions imposed by Principal which are available on Principal’s official website (www.principal.com.my). Please read all related Terms and Conditions as well as any other applicable terms of use and/or terms of conditions carefully before participating in this Promotion.

Promotion Period

3. Promotion Period is from 1st April 2024, 12.00 AM to 28th February 2025, 3.00 PM, both dates inclusive (“**Promotion Period**”).
4. Principal reserves its absolute right and discretion to vary or amend the Promotion Period and reward at any time without prior notice, without assigning any reason whatsoever.

Eligibility

5. To be eligible, a participant must fulfill the following criteria:
 - a) maintain minimum AUM of RM10,000 (Ten Thousand Ringgit Malaysia) via EPF fund in Principal DALI Equity Growth fund (“Fund”) (**non-cumulative**) at any time before the Promotion Period:

Promotion Mechanics and Conditions

6. To participate in the Promotion, the Eligible Participant shall comply with each of the following:
 - a) To switch a minimum RM10,000 (Ten Thousand Ringgit Malaysia) from **Principal DALI Equity Growth Fund** into any one of our recommended funds (EPF-MIS) or an existing active EPF-MIS funds at any time during the Promotion Period.

 - f) Customer who did not manage to Zeroize their investment amount by 28th February 2025, will still be eligible for the reward according to their qualifying tier, and be paid accordingly upon completion of confirmation and validation process (refer to Redemption Process)

Terms and Conditions of the Rewards

Redemption Process

12. Upon zeroizing of the investment amount in the delisted fund or after the end of this campaign, customer who qualifies for reward will be informed via email and SMS to contact the customer service for the process of verification prior to collection of reward.
13. Customer must contact customer service and undertake verification process after zeroizing their investment amount in the delisted fund or after the end of this campaign. Failure in doing so within 30 days of the notification of redemption via email and SMS will result in forfeiture of reward.
14. The Touch ‘n Go reward will be credited to the customer’s Touch ‘n Go account within 1 month after the claim is received and verification is completed. For example, if the claim is received in September, the reward will be credited by end of October (provided the verification is completed and details provided by the customer for redemption purpose is accurate and current). Any failure by the client to provide accurate or up-to-date information may result in delays or the inability to redeem rewards. This will also further lead to forfeiture of the rewards

- b) The Eligible Participants will be notified through the Touch 'n Go eWallet App and stated the reward is sent by Principal.
- c) Each Eligible Participant is only entitled to one TNG credit (one credit per Eligible Participant) during the Promotion Period regardless of number of switching transactions made.
- d) If the Eligible Participant doesn't have the Touch 'n Go eWallet App, Principal will email the TNG Reload Pin(s) to the registered email address which the Eligible Participant has provided to Principal.
- e) If the TNG Reload Pin(s) remains unused or unredeemed after the said Expiry Period, the TNG Reload Pin shall lapse and will not be replaced.

The usage of the TNG Reload PINs is subject to the Touch 'n Go eWallet User Terms and Conditions available in the Touch 'n Go eWallet official website. Eligible Participants are responsible to read and understand the Touch 'n Go's security and privacy policies and terms and conditions available in the Touch 'n Go eWallet official website.

Terms and Conditions of the Funds

- 18. The terms and conditions governing the Funds are specified in the relevant master prospectus(es), supplemental prospectus(es) or information memorandum thereto (if any) that have been duly lodged with the Securities Commission Malaysia which shall be governed by and regulated in accordance with the Capital Markets and Services Act 2007 (as amended from time to time) and the relevant guidelines and directives issued by the relevant authorities.
- 19. The Eligible Participant shall be solely liable to make their own independent evaluation of the Funds and any information made available pertaining to the Funds, including the relevant master prospectus(es), supplemental prospectus(es), or information memorandum thereto (if any) and seek independent financial, legal or other advice regarding the appropriateness of investing in any of the Funds. Any notification made by Principal for this Promotion may be communicated by e-mail, by way of a notice displayed on Principal's website or in any other manner deemed practical and those notifications will be immediately binding on the Eligible Participant upon dispatch of the email, display of such notice on Principal's website or delivery (in any other manner deemed practical), as applicable.
