

GOinvest Referral Campaign (“Campaign”) Terms & Conditions

1. The Campaign is organised by Principal Asset Management Berhad (199401018399 (304078-K)) (“**PAM**”).
2. The Campaign begins on 1st June 2023, 12:00 AM until 30th June 2023, 1:00 PM both dates inclusive (“**Campaign Period**”). The Campaign is open to any GOinvest user who makes a Successful Referral (as defined below) (“**Referrer**”). However, if any Referrer has been found performing certain actions on their account that are of high risk and not in line with [TNG Digital’s User Terms and Conditions](#), they will not be eligible to participate in this Campaign and TNG Digital reserves the right to disqualify them from this Campaign and they will not be entitled to the Reward (as defined below).
3. Each referral shall be deemed successful where:
 - (i) the new customer (“**Referee**”) successfully registers for a GOinvest account;
 - (ii) deposits a minimum of RM100 in their GOinvest account at any time by last day of the Campaign Period (as mentioned in the table below); 1:00 PM
