

## **GOinvest RM8 Cash Reward Campaign (“Campaign”) Terms & Conditions**

1. **GOinvest RM8 Cash Reward Campaign (“Campaign”)** is organised by TNG Digital Sdn Bhd (201701042478) (“**TNG Digital**”) and Principal Asset Management Berhad (199401018399 (304078-K) (“**PAM**”).
2. The Campaign begins on 1<sup>st</sup> March 2023, 12:00 AM until 31<sup>st</sup> March 2022, 1:00 PM both dates inclusive (“**Campaign Period**”).
3. The Campaign is open to new GOinvest users who make their first cash-in with a minimum of RM500 in a single transaction in their GOinvest account during the Campaign Period (“**Eligible Participant**”). However, if any GOinvest user has been found performing certain actions on their account that are of high risk and not in line with [TNG Digital’s User Terms and Conditions](#), they will not be eligible to participate in this Campaign and TNG Digital reserves any right to disqualify them from this Campaign and they will not be entitled to the reward.

The Eligible Participant is required to maintain at least a balance of RM500 in their GOinvest account throughout the post-campaign period being thirty (30) days from the end of the Campaign Period; from 1<sup>st</sup> April 2023 (“**Post Campaign Period**”). ## **Terma dan Syarat Kempen GOinvest RM8 Cash Reward**

1. Kempen GOinvest **RM8 Cash Reward** (“**Kempen**”) ini dianjurkan oleh TNG Digital Sdn Bhd (201701042478) (“**TNG Digital**”) dan Principal Asset Management Berhad 199401018399 (304078-K) (“**PAM**”).
2. Kempen ini akan bermula dari 1 Mac 2023, 12:00 AM sehingga 31 Mac 2023, termasuk kedua-dua tarikh (“**Tempoh Kempen**”).
3. Kempen ini terbuka kepada pengguna GOinvest jemputan yang membuat tunai masuk pertama dengan minimum RM500 dalam satu transaksi dalam akaun GOinvest mereka semasa Tempoh Kempen (“**Peserta Layak**”).
